



REVENUE BY OPERATING SEGMENT 按業務劃分之收入



REVENUE BY GEOGRAPHICAL INFORMATION 按地區劃分之收入



主席報告

Chairman's Statement

On behalf of the Board of Directors (the "Board"), I am pleased to report the annual audited results of the Company together with the subsidiaries (collectively the "Group") for the year ended 31 December 2014.

本人欣然代表董事會(「董事會」)提呈本公司 及其附屬公司(統稱「本集團」)截至二零一四 年十二月三十一日止年度之全年業績。

FINANCIAL RESULTS

The Group turnover for the year ended 31 December 2014 amounted to approximately HK\$465.3 million representing an 10.9% increase from the previous year. Overall gross profit amounted to approximately HK\$74.8 million this year representing an 2.4% increase from the previous year. Profit attributable to owners of the Company was approximately HK\$10.5 million (2013: HK\$26.0 million).

Basic earnings per share for the year ended 31 December 2014 was HK3.94 cents (2013: HK9.75 cents).

BUSINESS REVIEW

Benefited from the increasing demand of the major customers, along with the business came from the newly established customers, the turnover of the precision parts and components segment in 2014 increased by 18.3% to approximately HK\$361.5 million. The operating profit increased by 19.7% to approximately HK\$23.2 million. This included the loss of approximately HK\$1.5 million from the derivative financial instruments purchased to manage the impact of appreciation of Renminbi needed for the operating expenses of our factories in Mainland China.

Due to the continuous weakened demand from the market, the turnover of the consumer electronic products segment dropped by 8.9% to approximately HK\$103.7 million. Because of the change of product mix and the increase in manufacturing costs, the segment had turned from a gain into loss of approximately HK\$9.4 million. This included the loss of approximately HK\$0.4 million from the derivative financial instruments purchased to manage the impact of appreciation of Renminbi needed for the operating expenses of our factory in Mainland China.

Due to the uncertainty in the market and the high volatility of Renminbi exchange rate, the Group has decided to temporarily stop utilising the derivative financial instrument to manage the impact of appreciation of Renminbi needed for the operating expenses.

財務業績

截至二零一四年十二月三十一日止年度,本集團之營業額約為465,300,000港元,較去年上升10.9%。本年度整體毛利約74,800,000港元,較去年上升2.4%。本公司擁有人所佔溢利約為10,500,000港元(二零一三年:26,000,000港元)。

截至二零一四年十二月三十一日止年度,每股基本盈利為3.94港仙(二零一三年:9.75港仙)。

業務回顧

精密零部件分類業務持續增長,由於主要客戶的訂單增加及成功取得新客戶的訂單,二零一四年之營業額較去年上升18.3%至約361,500,000港元。盈利較去年增加19.7%至約23,200,000港元,其中包括為控制國內工廠營運開支因人民幣升值影響而購買的衍生金融工具錄得虧損約1,500,000港元。

電子消費品分類業務由於需求持續疲弱,營業額較去年下降8.9%至約103,700,000港元。因產品組合之改變及國內生產成本上升影響而由盈轉虧,錄得虧損約9,400,000港元,其中包括為控制國內工廠營運開支因人民幣升值影響而購買的衍生金融工具錄得虧損約400,000港元。

鑒於人民幣匯率的波幅擴大及市場變化,本 集團巳暫時停止使用衍生金融工具以控制營 運開支因人民幣升值的影響。

BUSINESS REVIEW (continued)

In 2014, the Group continued to record growth in business. The increase from the precision parts and components segment offset the decrease in business from the consumer electronic products segment. The rise in production costs and the operating loss in the consumer electronic products segment had driven the gross profit margin down by 1.3% to 16.1%. The selling and distribution costs increased by 3.3% to approximately HK\$33.6 million and administrative expenses also increased by 3.0% to approximately HK\$33.2 million. Due to the increase in debts financing, the finance costs had increased by 41.6% to approximately HK\$1.4 million.

Cash and cash equivalents for the Group at the end of reporting period were approximately HK\$35.3 million. The outstanding bank borrowings and finance lease payables was HK\$47.4 million. The shareholders' equity of the Group at the end of reporting period was approximately HK\$252.2 million (2013: HK\$255.0 million).

FUTURE PLANS AND PROSPECTS

Due to the increasing dominance of smartphones as an important personal electronics tool, the consumer electronic products segment will continue to face stiff challenge. The precision parts and components segment has successfully expanded the customer network in the past two years and continues to achieve steady growth in business. In order to fulfill customer needs, the Group had invested approximately HK\$38.6 million for the installation of new machines, equipment and facilities in the production of precision parts and components segment to enhance the production capability and efficiency. The investment was financed by internal resources and bank and other borrowings. The Group's financial position remains healthy, and is strong enough to finance its daily operation and invest to expand the business if needed. We can expect that the production costs in Mainland China will continue to rise and the production workers will be in shortage. Therefore, we will actively research and invest in production automation to increase production capability and improve profitability. In the coming year, we are still facing many uncertainties and will be very cautious but optimistic in our business.

業務回顧(續)

於二零一四年,本集團的業績繼續錄得增長,精密零部件分類業務持續增長抵消電子消費品分類業務的下跌。製造成本的上漲及電子消費品分類業務的虧損令整體毛利率較去年下降1.3%至16.1%。銷售及經銷成本上升3.3%至約33,600,000港元,行政費用上升3.0%至約33,200,000港元,融資成本因借貸上升而增加41.6%至約1,400,000港元。

本集團於報告期末的現金及現金等值項目結餘約為35,300,000港元,未償還銀行借貸及應付融資租賃約為47,400,000港元。本集團於報告期末之股東權益約為252,200,000港元(二零一三年:255,000,000港元)。

Management Discussion and Analysis

OPERATIONS REVIEW

The following highlights the Group's results for the year ended 31 December 2014.

- Turnover increased by 10.9% from the prior year to approximately HK\$465.3 million for the year.
- Gross profit increased by HK\$1.8 million from 2013 to approximately HK\$74.8 million in 2014.
- Profit from operating activities before finance costs was approximately HK\$13.0 million, a decrease of HK\$11.7 million from the last financial year.
- Finance costs increased by HK\$0.4 million from last year to approximately HK\$1.4 million.
- Profit after tax for the year was approximately HK\$10.5 million.

In the year under review, turnover of the precision parts and components segment has increased by approximately 18.3% as compared with the previous financial year. Turnover of the consumer electronic products segment has decreased by approximately 8.9% as compared with the prior year.

The Group's overall gross profit has increased by approximately 2.4% from the previous year.

The Group's finance costs have increased to approximately HK\$1.4 million for the year due to the increase in borrowings from banks and other financial institution.

LIQUIDITY AND FINANCIAL RESOURCES

The Group generally finances its operations with internally generated cash flow and loan facilities provided by its principal bankers and other financial institution in Hong Kong.

The total borrowings from banks and other financial institution include all term loans, finance leases, import and export loans, which amounted to approximately HK\$47.4 million as at 31 December 2014.

The Group's financial position remains healthy. At the end of the reporting period, the aggregate balance of cash and cash equivalents of the Group amounted to approximately HK\$35.3 million.

營運回顧

以下是本集團於截至二零一四年十二月三十 一日止年度主要業績概況。

- 營業額比去年上升10.9%至本年度約 465,300,000港元。
- 毛利相比二零一三年增加1,800,000港 元至二零一四年約74,800,000港元。
- 經營業務溢利於未計及融資成本前約 為13,000,000港元,較上財政年度減少11,700,000港元。
- 融資成本比去年增加400,000港元至約 1,400,000港元。
- 本年度除税後溢利約為10,500,000港 元。

回顧本年度,精密零部件分類業務之銷售營業額與上財政年度相比增加約18.3%。電子消費品分類業務之銷售營業額與去年相比下跌約8.9%。

本集團整體毛利較去年上升約2.4%。

本集團融資成本較去年增加至約1,400,000 港元是由於銀行及其他財務機構借貸之增加。

流動資金及資金來源

本集團一般以內部產生之現金流量及其香港 之主要往來銀行及其他財務機構所提供之備 用信貸作為其營運資金。

於二零一四年十二月三十一日,銀行及其他 財務機構借貸總額,包括銀行所有貸款、融 資租賃及進出口貸款約47,400,000港元。

本集團之財務狀況維持健康。於報告期末, 本集團之現金及現金等值項目之結餘總額約 35,300,000港元。

LIQUIDITY AND FINANCIAL RESOURCES (continued)

The Group's borrowings are on a floating rate basis and are mainly denominated in Hong Kong dollars or United States dollars. These match with the principal currencies in which the Group conducts its business.

The gearing ratio on the basis of net debt divided by the total capital plus net debt as at 31 December 2014 is 29.8% (2013: 22.0%).

CHARGE ON THE GROUP'S ASSETS

At 31 December 2014, the Group's machines and equipment with carrying amount of approximately HK\$35.5 million (2013: HK\$6.7 million) were pledged under finance leases.

CONTINGENT LIABILITIES

Except for corporate guarantees given to banks and other financial institution in relation to loan facilities granted to the subsidiaries, the Company had no other contingent liabilities as at 31 December 2014.

CAPITAL STRUCTURE

As at 31 December 2014, the Company had 267,004,800 ordinary shares in issue with total shareholders' equity of the Group amounting to approximately HK\$252.2 million.

FUND RAISING

Other than obtaining general loan facilities to finance the Group's trading requirements and finance leases to finance the acquisition of machines and equipment, the Group did not have any fund raising activities in 2014.

流動資金及資金來源(續)

本集團之貸款按浮動息率並以港元或美元結 算為主,而本集團名下之業務營運亦以該等 貨幣為主。

於二零一四年十二月三十一日,根據債項淨 值除以總資本加債項淨值之總和計算之負債 率為29.8%(二零一三年:22.0%)。

本集團已抵押資產

於二零一四年十二月三十一日,本集團之機器及設備之賬面值約為35,500,000港元(二零一三年:6,700,000港元)已作為融資租賃之抵押。

或然負債

於二零一四年十二月三十一日,除了本公司 授予銀行及其他財務機構給有關附屬公司的 備用貸款擔保外,並無其他或然負債。

資本結構

於二零一四年十二月三十一日,本公司之已發行股份為267,004,800股普通股,而本集團之總股東權益約252,200,000港元。

籌集資金

除了取得一般備用信貸以支付本集團之買賣 要求及融資租賃以支付購買機器及設備外, 本集團於二零一四年概無籌集資金。

EMPLOYEES

As at 31 December 2014, the Group had a total workforce of approximately 2,111 of which approximately 59 were based in Hong Kong, approximately 5 were based overseas and approximately 2,047 were based in Mainland China.

The Group remunerates its employees largely based on the prevailing industry practice and labour laws. Since December 1996, the Company has adopted a share option scheme for the purpose of providing incentives and rewards to the employees of the Group.

Moreover, under the Mandatory Provident Fund Scheme Ordinance of Hong Kong, the Group has operated a defined contribution Mandatory Provident Fund retirement benefits scheme for all its Hong Kong employees. For overseas and Mainland China employees, the Group is required to contribute a certain percentage of its payroll costs to the central pension scheme operated by the respective local governments.

於二零一四年十二月三十一日,本集團共有約2,111名僱員,其中約59名駐香港,約5名駐海外及約2,047名駐中國大陸。

本集團主要根據目前業內慣例及勞工法例釐 定僱員酬金。本公司自一九九六年十二月以 來已實行一項購股權計劃,目的是提供獎勵 及報酬予本集團僱員。

此外,本集團根據香港強制性公積金計劃條例,為於香港之所有僱員實施一項定額供款強制性公積金計劃。至於海外及中國大陸的僱員,本集團須要按照其當地政府所營辦的中央公積金,以僱員薪金的若干百分比作供款。

CORPORATE GOVERNANCE CODE

The Board of the Company believes that corporate governance is essential to the success of the Company and has adopted various measures to ensure that a high standard of corporate governance is maintained. The Company has applied the principles as set out in the Corporate Governance Code ("CG Code") contained in Appendix 14 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited ("Stock Exchange") ("Listing Rules") and regularly reviews its corporate governance codes to ensure compliance with the CG Code. In the opinion of the directors, the Company has complied with all the code provisions as set out in the CG Code throughout the year ended 31 December 2014, except for the deviation in respect of the separation of the roles of chairman and chief executive officer. Considered reasons are provided in the section of chairman and chief executive officer.

During the year ended 31 December 2014, the Board at all times met the requirements of the Listing Rules relating to the appointment of at least three independent non-executive directors representing more than one-third of the Board with at least one independent non-executive director possessing appropriate professional qualifications, or accounting or related financial management expertise.

企業管治守則

本公司董事會相信企業管治對本公司之成功 至為重要,並已採納多項措施以確保維持高 標準的企業管治。本公司應用香港聯合(「馬 所有限公司證券上市規則(「聯交所」)(「 市規則」)附錄十四所載的企業管治守則(「 業管治守則」)之原則及定期檢討企業管治守則, 以確保其遵守企業管治守則。董事認 ,惟當中有關主席及行政總裁之角色 是偏離外,本公司於截至二零一四年十二月 三十一日止整個年度均遵守載於企業管治守 則之所有守則條文。經考慮的理由列於主席 及行政總裁相關章節內。

Responsibilities and delegation of functions

The Board of the Company is collectively responsible for the oversight of the management of the business and affairs of the Group with the objective of enhancing shareholders' value. The overall management of the Company's business is vested in the Board. The Board has delegated the day-to-day management of the Company's business to the executive directors. In addition, the Board has established Board committees and has delegated to these Board committees various responsibilities as set out in their respective terms of reference.

The Board focuses its attention on matters affecting the Company's overall strategic policies, finances and shareholders. These include financial statements, dividend policy, significant changes in accounting policy, the annual operating budget, certain material contracts, strategies for future growth, major financing arrangements and major investments, risk management strategies, treasury policies and group structure.

The Board formulates overall strategy of the Group, monitors its financial performance and maintains effective oversight over the management. The Board members are fully committed to their roles and have acted in good faith to maximise the shareholders' value in the long run, and has aligned the Group's goals and directions with the prevailing economic and market conditions. Daily operations and administration are delegated to the management.

The Company has put in place appropriate insurance cover in respect of director's liability.

CORPORATE GOVERNANCE FUNCTION

The Company has not set up a corporate governance committee. The Board is responsible for performing the corporate governance duties set out hereunder:

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

Code Provision A.2.1 stipulates that the roles of chairman and chief executive officer should be separate and should not be performed by the same individual.

The roles of the chairman and the chief executive officer are not separate and are performed by Mr. Lai Pei Wor. Since the Board will meet regularly to consider major matters affecting the operations of the Company, the Board considers that this structure will not impair the balance of power and authority between the Board and the management of the Company and believes that this structure will enable the Company to make and implement decisions promptly and efficiently.

INDEPENDENT NON-EXECUTIVE DIRECTORS

All the independent non-executive directors have contracts with the Company for a specified period of two years and are appointed subject to retirement by rotation and re-election at the annual general meeting of the Company in accordance with the Company's Bye-laws and the CG Code.

Each independent non-executive director has made an annual confirmation of independence to the Company and the Company considers these directors to be independent under Rule 3.13 of the Listing Rules. None of the directors is related to each other.

Mr. Kung Fan Cheong who has been serving as Independent Non-executive Director of the Company for more than 9 years, has confirmed his independence with reference to the factors set out in Rule 3.13 of the Listing Rules. The Company considers Mr. Kung Fan Cheong is still independent in accordance with the independence guidelines set out in the Listing Rules and will continue to bring valuable business experience, knowledge and professionalism to the Board for its efficient and effective functioning.

DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted the code of conduct regarding directors' securities transactions as set out in the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") of Appendix 10 of the Listing Rules. Based on specific enquiry of the Company's directors, all directors have complied with the required standard set out in the Model Code throughout the year.

The majority of the current members of each Board committee (except Executive Committee) are independent non-executive directors, while all the members of the Executive Committee are executive directors.

The Board committees are provided with sufficient resources to discharge their duties and, upon reasonable request, are able to seek independent professional advice in appropriate circumstances at the Company's expense.

EXECUTIVE COMMITTEE

The directors acknowledge their responsibility for preparing the financial statements of the Group for the year ended 31 December 2014. The directors ensure the preparation of the financial statements of the Group are in accordance with statutory requirements and applicable accounting standards. The directors also ensure the publication of the financial statements of the Group is in a timely manner.

The statement of the Auditor of the Company about their reporting responsibilities on the financial statements is set out in the Independent Auditor's Report on pages 38 and 39.

INTERNAL CONTROL

The Board has overall responsibility for maintaining a sound and effective internal control system of the Group. The Group's internal control system includes a well defined management structure with limits of authority which is designed to help the Group to achieve its business objectives, safeguard its assets against unauthorised use or disposition, ensure proper maintenance of books and records for the provision of reliable financial information for internal use or publication, and ensure compliance with relevant legislations and regulations. Such procedures are designed to provide reasonable, but not absolute, assurance against material misstatement or loss, and to manage rather than eliminate risk of failure in the Group's operational systems and in the achievement of the Group's business objectives.

During the year, the effectiveness of the internal control system and risk management system of the Group were reviewed. The review has covered the financial, operational, compliance and risk management aspects of the Group including the adequacy of resources, qualifications and experience of staff of the Company's accounting and financial reporting function, and their training programmes and budget. The requisition must specify the purpose of the meeting, and must be signed by the relevant requisitionist(s) and deposited at the head office of the Company in Hong Kong.

1. CORPORATE INFORMATION

K & P International Holdings Limited (the "Company") is a limited liability company incorporated in Bermuda. Its registered office is located at Units 2304-06, 23rd Floor, Riley House, 88 Lei Muk Road, Kwai Chung, New Territories, Hong Kong.

During the year, the Company and its subsidiaries (together the "Group") were involved in the following principal activities:

- manufacture and sale of precision parts and components (comprising keypads, synthetic rubber and plastic components and parts, and liquid crystal displays); and
- design, manufacture and sale of consumer electronic products (comprising time, weather forecasting and other products).

There were no significant changes in the nature of the Group's principal activities during the year.

2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs"), which collective term includes all applicable Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"), accounting principles generally accepted in Hong Kong and the disclosure requirements of the predecessor Hong Kong Companies Ordinance (Cap. 32). These financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules"). These financial statements have been prepared under the historical cost convention, except for land and buildings, derivative financial instruments and an available-for-sale financial investment, which have been measured at revalued amount/fair value as explained in the accounting policies set out below. These financial statements are presented in Hong Kong dollars.

Basis of consolidation

The consolidated financial statements comprise the financial statements of the Company and all of its subsidiaries as at 31 December each year. The financial statements of the subsidiaries are prepared for the same reporting period as that of the Company using consistent accounting policies.

All intra-group balances, transactions, income and expenses resulting from intra-group transactions are eliminated in full. The results of subsidiaries are consolidated from the date on which the Group obtains control and continue to be consolidated until the date that such control ceases.

Allocation of total comprehensive income

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent and to the non-controlling interests. Total comprehensive income is attributed to the owners of the Company and the non-controlling interest even if this results in the non-controlling interest having a deficit balance.

Changes in ownership interest

Changes in the Group's ownership interest in a subsidiary that do not result in a loss of control are accounted for as equity transactions. The carrying amounts of the controlling and non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiary. Any difference between the amount by which the non-controlling interests are adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to the owners of the Company.

When the Group loses control of a subsidiary, the gain or loss on disposal is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest determined at the date when control is lost and (ii) the carrying amount of the assets (including goodwill), and liabilities of the subsidiary and any non-controlling interests at the date when control is lost. The amounts previously recognised in other comprehensive income in relation to the disposed subsidiary are accounted for on the same basis as would be required if the parent had directly disposed of the related assets or liabilities. Any investment retained in the former subsidiary and any amounts owed by or to the former subsidiary are accounted for as a financial asset, associate, joint venture or others as appropriate from the date when control is lost.

A summary of other principal accounting policies adopted by the Group is set out in note 2.4 to the financial statements.

2.2 CHANGES IN ACCOUNTING POLICIES AND DISCLOSURES

In the current year, the Group has applied the following new/revised HKFRSs for the first time. Other than as further explained, the adoption of the new/revised HKFRSs has had no significant impact on the financial statements of the Group.

Amendments to HKAS 32: Presentation – Offsetting Financial Assets and Financial Liabilities

The amendments to HKAS 32 clarify the requirements for offsetting financial instruments. These amendments do not have an impact on the consolidated financial statements as they are consistent with the policies already adopted by the Group.

Amendments to HKAS 36: Recoverable Amount Disclosures for Non-Financial Assets

The amendments to HKAS 36 modify the disclosure requirements for impaired non-financial assets. Among them, additional information is required to be disclosed when the recoverable amount of impaired assets is based on fair value less costs of disposal. These amendments do not have an impact on the consolidated financial statements.

 - (iv) One entity is a joint venture of a third entity and the other entity is an associate of the third entity.
 - (v) The entity is a post-employment benefit plan for the benefit of employees of either the Group or an entity related to the Group. If the Group is itself such a plan, the sponsoring employers are also related to the Group.

The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use. Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the income statement in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciation.

Land and buildings are stated at revalued amount, being the fair value at the date of valuation less accumulated depreciation and accumulated impairment losses. Valuations are performed frequently to ensure that the fair value of a revalued asset does not differ materially from its carrying amount. Changes in the values of property, plant and equipment are dealt with as movements in the asset revaluation reserve. Decrease in valuation are first offset against increase on earlier valuations in respect of the same asset and thereafter charged to profit or loss. Any subsequent revaluation surplus is credited to the income statement to the extent of the deficit previously charged.

As the Group's lease payments for its leasehold land and buildings cannot be allocated reliably between the land and buildings elements at the inception of the lease because similar land and buildings are not sold or leased separately, the entire lease payments are included in the cost of the leasehold land and buildings as a finance lease in property, plant and equipment.

Depreciation is calculated on the straight-line basis to write off the cost or valuation of each item of property, plant and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property, plant and equipment and any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in the income statement in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset. On disposal of a revaluated asset, the relevant portion of the asset revaluation reserve realised in respect of previous valuations is transferred to retained profits as a movement in reserves.

Intangible assets (other than goodwill)

Intangible assets acquired separately are measured on initial recognition at cost. The cost of intangible assets acquired in a business combination is the fair value as at the date of acquisition. The useful lives of intangible assets are assessed to be either finite or indefinite. Intangible assets with finite lives are subsequently amortised over the useful lives and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at each financial year end.

Intangible assets with indefinite useful lives are tested for impairment annually either individually or at the cash-generating unit level. Such intangible assets are not amortised. The useful life of an intangible asset with an indefinite life is reviewed annually to determine whether indefinite life assessment continues to be supportable. If not, the change in the useful life assessment from indefinite to finite is accounted for on a prospective basis.

Development costs

Expenditure incurred on projects to develop new products is capitalised and deferred only when the Group can demonstrate the followings: 1) the technical feasibility of completing the project related to the intangible asset so that it will be available for use or sale; 2) its intention to complete and its ability to use or sell the asset; 3) how the asset will generate future economic benefits; 4) the availability of resources to complete the project; and 5) the ability to measure reliably the expenditure during the development. Product development expenditure which does not meet these criteria is expensed when incurred.

Deferred development costs are stated at cost less accumulated amortisation and any impairment losses and are amortised using the straight-line basis over the commercial lives of the underlying products (not exceeding five years), commencing from the date when the products are put into commercial production.

Licenses

Licenses are stated at cost less accumulated amortisation and any impairment losses and are amortised on the straight-line basis over their estimated useful lives of five years.

Leases

Leases that transfer substantially all the rewards and risks of ownership of assets to the Group are accounted for as finance leases. All other leases are classified as operating leases. At the inception of a finance lease, the cost of the leased asset is capitalised at the lower of the fair value of the leased assets and the present value of the minimum lease payments. The corresponding liability to the lessor is included in the statement of financial position as finance lease obligation. Assets held under capitalised finance leases are recognised as assets of the Group. The finance costs of such leases are charged to the income statement so as to provide a constant periodic rate of charge over the lease term.

Rentals payable under operating leases net of any incentives are charged to the income statement on the straight-line basis over the lease term.

This category includes derivative financial instruments entered into by the Group that are not designated as hedging instruments in hedge relationships as defined by HKAS 39. Derivatives are also classified as held for trading unless they are designated as effective hedging instruments. Financial assets at fair value through profit or loss are carried in the statement of financial position at fair value with changes in fair value recognised in the income statement. These net fair value changes do not include any dividends or interest earned on these financial assets.

The Group evaluates its financial assets at fair value through profit or loss (held for trading) to assess whether the intent to sell them in the near term is still appropriate. When the Group is unable to trade these financial assets due to inactive markets and management's intent to sell them in the foreseeable future significantly changes, the Group may elect to reclassify these financial assets in rare circumstances. The reclassification from financial assets at fair value through profit or loss to loans and receivables, available-for-sale financial investments or held-to-maturity investments depends on the nature of the assets. This evaluation does not affect any financial assets designated at fair value through profit or loss using the fair value option at designation and derivative financial assets.

Loans and receivables

Loans and receivables including cash and cash equivalents, trade and bills receivable, and deposits and other receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market and are not held for trading. They are measured at amortised cost using the effective interest method, except where receivables are interest-free loans and without any fixed repayment term or the effect of discounting would be insignificant. In such case, the receivables are stated at cost less impairment loss. Amortised cost is calculated by taking into account any discount or premium on acquisition over the period to maturity. Gains and losses arising from derecognition, impairment or through the amortisation process are recognised in the income statement.

After initial recognition, available-for-sale financial investments are subsequently measured at fair value, with unrealised gains or losses recognised as other comprehensive income in the available-for-sale financial investment valuation reserve until the investment is derecognised, at which time the cumulative gain or loss is recognised in the income statement in other income, or until the investment is determined to be impaired, at which time the cumulative gain or loss previously reported in other comprehensive income shall be reclassified to profit or loss as a reclassification adjustment. Interest and dividends earned are reported as interest income and dividend income in the income statement respectively.

When the fair value of unlisted equity securities cannot be reliably measured because (a) the variability in the range of reasonable fair value estimates is significant for that investment or (b) the probabilities of the various estimates within the range cannot be reasonably assessed and used in estimating fair value, such securities are stated at cost less any impairment losses.

The Group evaluates its available-for-sale financial investments whether the ability and intention to sell them in the near term are still appropriate. When the Group is unable to trade these financial assets due to inactive markets and management's intent to do so significantly changes in the foreseeable future, the Group may elect to reclassify these financial assets in rare circumstances. Reclassification to loans and receivables is permitted when the financial assets meet the definition of loans and receivables and the Group has the intent and ability to hold these assets for the foreseeable future or to maturity. - the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if and to what extent it has retained the risks and rewards of ownership. Impairment of financial assets

The Group assesses at the end of each reporting period whether there is any objective evidence that a financial asset or a group of financial assets other than financial assets at fair value through profit or loss is impaired. A financial asset or a group of financial assets is deemed to be impaired if, and only if, there is objective evidence of impairment as a result of one or more events that has occurred after the initial recognition of the asset (an incurred "loss event") and that loss event has an impact on the estimated future cash flows of the financial asset or the group of financial assets that can be reliably estimated. Evidence of impairment may include indications that a debtor or a group of debtors is experiencing significant financial difficulty, default or delinquency in interest or principal payments, the probability that they will enter bankruptcy or other financial reorganisation and observable data indicating that there is a measurable decrease in the estimated future cash flows, such as changes in arrears or economic conditions that correlate with defaults.

Financial assets carried at amortised cost

For financial assets carried at amortised cost, the Group first assesses individually whether objective evidence of impairment exists for financial assets that are individually significant, or collectively for financial assets that are not individually significant. If the Group determines that no objective evidence of impairment exists for an individually assessed financial asset (whether significant or not), it includes the asset in a group of financial assets with similar credit risk characteristics and collectively assesses them for impairment. Assets that are individually assessed for impairment and for which an impairment loss is, or continues to be, recognised are not included in a collective assessment of impairment.

If there is objective evidence that an impairment loss has been incurred, the amount of the loss is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows (excluding future credit losses that have not been incurred). The present value of the estimated future cash flows is discounted at the financial asset's original effective interest rate (i.e., the effective interest rate computed at initial recognition). If a loan has a variable interest rate, the discount rate for measuring any impairment loss is the current effective interest rate.

The carrying amount of the asset is reduced through the use of an allowance account and the amount of the loss is recognised in the income statement. Interest income continues to be accrued on the reduced carrying amount and is accrued using the rate of interest used to discount the future cash flows for the purpose of measuring the impairment loss. Loans and receivables together with any associated allowance are written off when there is no realistic prospect of future recovery.

If, in a subsequent period, the amount of the estimated impairment loss increases or decreases because of an event occurring after the impairment was recognised, the previously recognised impairment loss is increased or reduced by adjusting the allowance account. If a future write-off is later recovered, the recovery is credited to the income statement.

Available-for-sale financial investments

For available-for-sale financial investments, the Group assesses at the end of each reporting period whether there is objective evidence that an investment or a group of investments is impaired.

If an available-for-sale financial asset is impaired, an amount comprising the difference between its cost (net of any principal payment and amortisation) and its current fair value, less any impairment loss previously recognised in the income statement, is reclassified from equity to profit or loss as a reclassification adjustment.

可供出售金融投資

就可供出售金融投資,本集團將於每個報告期末評估有否客觀跡象會導致一項 投資或一組投資出現減值。

如果可供出售金融資產有減值,金額包括其成本(扣除本金付款及攤銷)與其近期公平價值的差額減任何過往已確認於利潤表的減值虧損,會重新分類由權益至損益賬為重新分類調整。

Available-for-sale financial investments (continued)

In the case of equity investments classified as available for sale, objective evidence would include a significant or prolonged decline in the fair value of an investment below its cost. The determination of what is "significant" or "prolonged" requires judgement. "Significant" is evaluated against the original cost of the investment and "prolonged" is evaluated against the period in which the fair value has been below its original cost. Where there is evidence of impairment, the cumulative loss (measured as the difference between the acquisition cost and the current fair value, less any impairment loss on that investment previously recognised in the income statement) is reclassified from other comprehensive income and recognised in the income statement. Impairment losses on equity instruments classified as available for sale are not reversed through the income statement. Increases in their fair value after impairment are recognised directly in other comprehensive income.

In the case of debt instruments classified as available for sale, impairment is assessed based on the same criteria as financial assets carried at amortised cost. However, the amount recorded for impairment is the cumulative loss (measured as the difference between the amortised cost and the current fair value, less any impairment loss on that investment previously recognised in the income statement). Impairment losses on debt instruments are reversed through the income statement, if the increase in fair value of the instruments can be objectively related to an event occurring after the impairment loss was recognised in the income statement.

Financial liabilities

Initial recognition and measurement

Financial liabilities are classified as financial liabilities at fair value through profit or loss, loans and borrowings, or as derivatives designated as hedging instruments in an effective hedge, as appropriate. The Group determines the classification of its financial liabilities at initial recognition.

All financial liabilities are recognised initially at fair value and in the case of loans and borrowings, net of directly attributable transaction costs.

The Group's financial liabilities include trade and other payables, derivative financial instruments and interest-bearing bank and other borrowings.

Subsequent measurement

The measurement of financial liabilities depends on their classification as follows:

Financial liabilities at fair value through profit or loss

Financial liabilities at fair value through profit or loss includes financial liabilities held for trading and financial liabilities designated upon initial recognition as at fair value through profit or loss.

Financial liabilities are classified as held for trading if they are acquired for the purpose of selling in the near term. This category includes derivative financial instruments entered into by the Group that are not designated as hedging instruments in hedge relationships as defined by HKAS 39. Separated embedded derivatives are also classified as held for trading unless they are designated as effective hedging instruments. Gains or losses on liabilities held for trading are recognised in the income statement. The net fair value gain or loss recognised in the income statement does not include any interest charged on these financial liabilities.

初步確認及計量

金融負債按適當的形式劃分為按公平價值計入損益的金融負債、貸款及借貸或 指定為有效對沖中對沖工具的衍生工 具。本集團於初步確認時釐定其金融負 債的分類。

所有金融負債初步按公平價值確認,而 如屬貸款及借貸,則直接應佔交易成本 淨額。

本集團的金融負債包括應付及其他應付 款項、衍生金融工具及帶息銀行及其他 借貸。

隨後計量

以公平價值計入損益的金融負債包括為 交易而持有的金融負債和初始確認時指 定為以公平價值計入損益的金融負債。

Loans and borrowings

After initial recognition, interest-bearing bank and other borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial. Gains and losses are recognised in the income statement when the liabilities are derecognised as well as through the effective interest rate method amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in the income statement.

Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the income statement.

Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position when, and only when, there is currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the asset and settle the liability simultaneously. The legally enforceable right must not be contingent on future events and must be enforceable in the normal course of business and in the events of default, insolvency or bankruptcy of the company or the counterparty.

貸款及借貸

於初步確認後,帶息銀行及其他借貸於 其後採用實際利率法按攤銷成本計量, 除非貼現之影響不大。在負債取消確認 及透過實際利率法攤銷程序進行時,收 益及虧損在利潤表中確認。

攤銷成本於計及收購事項任何折讓或溢 價及屬實際利率不可或缺一部分的費用 或成本後計算。實際利率攤銷計入利潤 表的融資成本內。

取消確認金融負債

倘金融負債的責任被解除、取消或到 期,則須取消確認金融負債。

倘現有金融負債被來自同一貸款人之另一項負債按實質上不相同之條款替代,或現有負債之條款大部份被修訂,該項交換或修訂作為取消確認原有負債及確認新負債處理,兩者相應賬面值之差額於利潤表內確認。

抵銷金融工具

僅限於當現時存在一項可依法執行的權利,可抵銷已確認金額,且亦有意以淨額結算或同時變現資產及償付債務,則財務資產及負債均可予抵銷,並將淨金額列入財務狀況表內。有關法定行使之權利無須按將來的或然事項,並必須行使於一般業務過程中及本公司或對方所產生之違約、無力償還或破產的事項上。

Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the first-in, first-out basis and, in the case of work in progress and finished goods, comprises direct materials, direct labour and an appropriate proportion of overheads. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and disposal.

When inventories are sold, the carrying amount of those inventories is recognised as an expense in the period in which the related revenue is recognised. The amount of any write-down of inventories to net realisable value and all losses of inventories are recognised as an expense in the period of the write-down or loss occurs. The amount of any reversal of any write-down of inventories is recognised as a reduction in the amount of inventories recognised as an expense in the period in which the reversal occurs.

Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the statements of financial position, cash and cash equivalents comprise cash on hand and at banks (including term deposits), which are not restricted as to use.

存貨

存貨按成本值及可變現淨值之較低者列 賬。成本值以先進先出基準計算,倘為 在製品及製成品,則包括直接材料、直 接勞工及間接成本之適當部份。可變現 淨值乃根據估計售價減預期達致完成及 出售之成本計算。

出售存貨時,該等存貨的賬面值於有關 收入確認期間內確認為開支。存貨撇減 至可變現淨值的任何金額及所有存貨虧 損均於撇減或虧損發生期間內確認為開 支。任何存貨撇減的任何撥回,於撥回 期間作為所確認存貨金額的減少而確認 為開支。

現金及現金等值項目

於編製綜合現金流量表時,現金及現金 等值項目包括現金及按要求之存款及短 期高度流通之投資,該等投資可隨時兑 換為可知數額之現金,而該等現金毋須 承受價值變動之重大風險,並一般在購 入時至到期時限不超過三個月之短期限 制,及減去按要求償還之銀行透支,而 該等投資乃本集團現金管理的一部份。

於編製財務狀況表時,現金及現金等 值項目指現金及銀行存款(包括定期存 款),其用途並無限制。

Impairment of other assets

Other than deferred tax assets, inventories and financial assets within the scope of HKAS 39, where an indication of impairment exists, or when annual impairment testing for an asset is required, the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's value in use and its fair value less costs to sell, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cashgenerating unit to which the asset belongs.

An impairment loss is recognised only if the carrying amount of an asset or a cash generating unit exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset or the cash-generating unit. An impairment loss is charged to the income statement in the period in which it arises, unless the asset is carried at a revalued amount, in which case the impairment loss is accounted for in accordance with the relevant accounting policy for that revalued asset.

An assessment is made at the end of each reporting period as to whether there is any indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset (other than goodwill) is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to the income statement in the period in which it arises, unless the asset is carried at a revalued amount, in which case the reversal of the impairment loss is accounted for in accordance with the relevant accounting policy for that revalued asset.

其他資產減值

香港會計準則第39號所界定內之遞延稅 項資產、存貨及金融資產以外,當有跡 象顯示減值或當資產需要進行年度減值 測試時,需預計資產的可收回金額。 產的可收回金額以資產的使用價值,或 其公平價值減去銷售成本兩者的較高者 計算,並就個別資產釐定,除非資產或 會產生頗大程度獨立於其他資產或資 組合的現金流入,在此情況下可收回金 額則以資產所屬的現金產生單位釐定。

如資產之賬面值或現金產生單位超逾其可收回金額時,減值虧損方予確認。於評估使用價值時,估計日後現金流量按反映現時市場評估的貨幣時間值及資產特定風險或現金產生單位的除稅前折現率折減至現值。減值虧損於產生期間自利潤表扣除,除非該資產以重估價值列賬,在該情況下,減值虧損根據有關重估資產之會計政策入賬。

於每個報告期末會評估是否有任何跡象顯示過往已確認的減值虧損不再存在或減少。倘出現該等跡象,則會估計可包含額。過往確認的資產減值虧損(商譽除外),僅用於釐定資產可收回金額的估計改變時撥回,惟撥回後的數額不得高於過往年度若並無就資產確認減值虧損而應有的賬面值。減值虧損的撥產人程,除非該資產的提面付價值列賬,在此情況下,減值虧損根據重估資產相關之會計政策入賬。

Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in the income statement.

Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities for the current and prior periods are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

撥備

因過去發生的事件而導致目前須承擔責任(法律或推定責任),並可能導致將來有資源流失以支付該責任,而該責任的金額能夠可靠估計時,撥備即予確認。

當有重大折現影響時,會就預期須用作 支付責任的日後開支於報告期末確認其 現值作撥備。因時間值所導致折現現值 的金額增加,會列入利潤表的融資成 本。

所得税

所得税包括本期及遞延税項。有關損益 外確認項目的所得税於損益外確認,不 論是否在其他全面收入或直接在權益 內。

本期間及過往期間的本期税項資產及負債,乃根據已頒佈或於報告期末已大致頒佈的稅率(及稅法),並考慮本集團業務所在國家的現有詮釋及慣例,按預期自稅務機構退回或付予稅務當局的金額計算。

於報告期末,資產與負債的稅基與作為 財務申報用途的資產與負債賬面值之間 的所有暫時性差異,須按負債法遞延稅 項撥備。

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- where the deferred tax liability arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of taxable temporary differences associated with investments in subsidiaries, where the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax assets are recognised for all deductible temporary differences, carryforward of unused tax credits and unused tax losses, to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carryforward of unused tax credits and unused tax losses can be utilised, except:

- where the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of deductible temporary differences associated with investments in subsidiaries, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

所有應課税暫時性差異均會確認為遞延 税項負債,惟以下情況例外:

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and deferred tax liabilities are offset if a legally enforceable right exists to set off current tax assets against current tax liabilities and the deferred taxes relate to the same taxable entity and the same taxation authority.

Revenue recognition

Revenue is recognised when it is probable that the economic benefits will flow to the Group and when the revenue can be measured reliably, on the following bases:

From the sale of goods, when the significant risks and rewards of ownership have been transferred to the buyer, provided that the Group maintains neither managerial involvement to the degree usually associated with ownership, nor effective control over the goods sold.

Dividends

Final dividends proposed by the directors are classified as a separate allocation of retained profits within the equity section of the statement of financial position, until they have been approved by the shareholders in a general meeting. When these dividends have been approved by the shareholders and declared, they are recognised as a liability.

遞延税項資產的賬面值,在每個報告期 末予以審閱,及若不再可能有足夠應課 税溢利用以抵扣全部或部分相關遞延税 項資產,則扣減遞延税項資產賬面值。 未被確認的遞延税項資產會於各報告期 末重新評估,並在可能有足夠應課税利 潤以收回全部或部分遞延税項資產時予 以確認。

確認資產或償還負債的期間預期適用的 税率,會用作衡量遞延税項資產及負債,並以報告期末當日已經生效或大致 上已經生效的税率(及稅法)為基準。

倘現有可依法執行權利,容許本期稅項 資產抵銷本期稅項負債,而該遞延稅項 涉及同一稅務實體及同一稅務機關,則 遞延稅項資產及遞延稅項負債予以對銷。

收入確認

收入會於本集團可能獲得有關經濟利益 及有關收益可以可靠地計算時按以下基 準確認:

銷售貨品,當擁有權之重大風險及回報 已歸買方,而本集團對已出售之貨品並 無維持一般與擁有權有關之管理參與或 實際控制。

股息

董事建議的末期股息,於財務狀況表中的權益內另外列作保留溢利的分配項目,直至在股東大會獲得股東批准。股息獲得股東通過及宣派後,方確認為負債。

Interim dividends are simultaneously proposed and declared, because the Company's memorandum and articles of association grant the directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

Share-based payment transactions

The Company operates a share option scheme for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. Employees (including directors) of the Group receive remuneration in the form of share-based payment transactions, whereby employees render services as consideration for equity instruments ("equity-settled transactions").

The cost of equity-settled transactions with employees for grants is measured by reference to the fair value at the date at which they are granted.

The cost of equity-settled transactions is recognised, together with a corresponding increase in equity, over the period in which the performance and/or service conditions are fulfilled. The cumulative expense recognised for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group's best estimate of the number of equity instruments that will ultimately vest. The charge or credit to the income statement for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

No expense is recognised for awards that do not ultimately vest, except for equity-settled transactions where vesting is conditional upon a market or non-vesting condition, which are treated as vesting irrespective of whether or not the market or non-vesting condition is satisfied, provided that all other performance and/ or service conditions are satisfied.

由於公司細則授予董事會權力宣派中期 股息,建議中期股息可即時宣派。因 此,中期股息於建議派發及宣派時直接 確認為負債。

以股份支付款項之交易

本公司為提供獎勵及回報予對本集團業務作出貢獻之合資格參與者設立一項購股權計劃。本集團僱員(包括董事)收取包括以股份支付款項交易在內之酬金,僱員則提供服務作為收取股本工具(「股本結算交易」)之代價。

與僱員進行股本結算交易之成本乃參照 授出相關工具當日的公平價值計算。

股本結算交易之成本值連同股本之相應 增長會於達到表現及/或服務條件之期 間內確認。由各報告期末直至歸屬日就 權益結算交易確認之累計開支反映歸 屬期屆滿之程度,以及本集團就最終將 歸屬之權益工具數目所作之最佳估計。 某期間自利潤表扣除或計入利潤表之項 目指於期初及期末確認之累計開支的變 動。

最終未能歸屬之報酬不會確認為開支,除非股本結算交易須待達到某市場或非歸屬條件後方可歸屬,在此情況下,不論是否達到該市場或非歸屬條件均會被視作歸屬處理,惟必須達到其他所有表現及/或服務條件。

Where the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified, if the original terms of the award are met. In addition, an expense is recognised for any modification, that increases the total fair value of the share-based payment transaction, or is otherwise beneficial to the employee as measured at the date of modification

When the share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share options reserve will be transferred to retained profits.

Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. This includes any award where non-vesting conditions within the control of either the Group or the employee are not met. However, if a new award is substituted for the cancelled award, and is designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award, as described in the previous paragraph. All cancellations of equity-settled transaction awards are treated equally.

Equity-settled share-based payment transactions with parties other than employees are measured at fair value of the goods or services received, except where the fair value cannot be reliably estimated, in which case they are measured at the fair value of the equity instruments granted. In all cases, the fair value is measured at the date the Group obtains the goods or the counterparty renders the services.

The dilutive effect of outstanding options is reflected as additional share dilution in the computation of earnings per share.

Employee benefits

Short term employee benefits

Salaries, annual bonuses, paid annual leave, contributions to defined contribution retirement plans and the cost of non-monetary benefits are accrued in the year in which the associated services are rendered by employees. Where payment or settlement is deferred and the effect would be material, these amounts are stated at their present values.

Retirement benefit schemes

The Group operates a defined contribution Mandatory Provident Fund retirement benefits scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance in Hong Kong for all of its eligible employees. Contributions are made based on a percentage of the employees' basic salaries and are charged to the income statement as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

The employees of the Group's subsidiaries which operate in Mainland China are required to participate in a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute certain percentage of their payroll costs to the central pension scheme. The contributions are charged to the income statement as they become payable in accordance with the rules of the central pension scheme.

Foreign currencies

These financial statements are presented in Hong Kong dollars (which is the Company's functional and presentation currency). Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by entities in the Group are initially recorded using their respective functional currency rates ruling at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are retranslated at the functional currency rates of exchange ruling at the end of the reporting period. All differences are taken to the income statement. Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was determined.

The results and financial position of all the group entities have a functional currency different from the presentation currency are translated into Hong Kong dollars, the presentation currency. As at the end of the reporting period, the assets and liabilities of these entities are translated into the presentation currency of the Company at the exchange rates ruling at the end of the reporting period and their income statements are translated into Hong Kong dollars at the weighted average exchange rates for the year. The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve. On disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in the income statement.

For the purpose of the consolidated statement of cash flows, the cash flows of overseas subsidiaries are translated into Hong Kong dollars at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of overseas subsidiaries which arise throughout the year are translated into Hong Kong dollars at the weighted average exchange rates for the year.

Estimates and assumptions concerning the future and judgements are made by the management in the preparation of the consolidated financial statements. They affect the application of the Group's accounting policies, reported amounts of assets, liabilities, income and expenses, and disclosures made. They are assessed on an on-going basis and are based on experience and relevant factors, including expectations of future events that are believed to be reasonable under the circumstances. Where appropriate, revisions to accounting estimates are recognised in the period of revision and future periods, in case the revision also affects future periods.

Inventories

The Group does not have a general provisioning policy on inventories based on ageing given that the inventories are not subject to frequent wear and tear or frequent technological changes. However, as a significant portion of the working capital is devoted to inventories, operational procedures have been in place to monitor this risk. The Group reviews the inventory ageing listing on a periodical basis for those aged inventories. This involves comparison of the carrying value of the aged inventory items with the respective net realisable value. The purpose is to ascertain whether allowance is required to be made in the financial statements for any obsolete and slow-moving items. In addition, physical counts on all inventories are carried out on a periodical basis in order to determine whether the allowance needs to be made in respect of any obsolete and defective inventories identified.

Trade receivables

In judging whether allowances for estimated irrecoverable amounts of the trade receivables have to be recognised in the financial statements, the Group takes into consideration if there is objective evidence that the Group will not be able to collect the debts. Following the identification of doubtful debts, the Group's responsible personnel discuss with the relevant customers and report to management on the recoverability. Specific allowance is only made for receivables that are unlikely to be collected.

Estimated useful lives of property, plant and equipment and other intangible assets

In assessing the estimated useful lives of property, plant and equipment and other intangible assets, the Group takes into account factors like the expected usage of the assets by the Group based on past experience, the expected physical wear and tear, and the technical obsolescence arising from changes or improvements in production or from a change in the market demand for the products. The estimation of the useful lives is a matter of judgement based on the experience of the Group.

Impairment of property, plant and equipment and other intangible assets

Property, plant and equipment and other intangible assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. The recoverable amounts of property, plant and equipment and other intangible assets have been determined based on value-in-use calculations. These calculations and valuations require the use of judgements and estimates. At 31 December 2014, no impairment losses have been recognised for property, plant and equipment and other intangible assets (2013: Nil). The carrying amount of property, plant and equipment was HK\$214,615,320 (2013: HK\$186,415,614) and the carrying amount of other intangible assets was nil at 31 December 2014 (2013: Nil).

Deferred tax assets

Deferred tax assets are recognised for all unused tax losses to the extent that it is probable that taxable profit will be available against which the losses can be utilised. Significant management judgement is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and level of future taxable profits together with future tax planning strategies. The carrying value of deferred tax assets relating to recognised tax losses was nil at 31 December 2014 (2013: HK\$434,200).

Current income taxes and deferred tax liabilities

The Group is subject to income taxes in Hong Kong, Mainland China and Singapore. Significant judgement is required in determining the amount of the provision for tax and the timing of payment of the related taxes. There are transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of business. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact on the income tax and deferred tax provisions in the periods in which such determination is made. The carrying amounts of tax payable and deferred tax liabilities at 31 December 2014 were HK\$6,299,396 (2013: HK\$9,122,965) and HK\$9,295,324 (2013: HK\$8,503,908) respectively.

Valuation of land and buildings

The Group's land and buildings included in property, plant and equipment are stated at their revalued amounts in the consolidated statement of financial position, which are assessed annually by management with reference to valuations performed by independent professionally qualified valuers. In determining the revalued amounts, the valuers have based on the method of valuations which involve certain estimates. In relying on the valuation reports, the directors of the Group have exercised their judgement and are satisfied that the method of valuations is reflective of the current market conditions. The carrying amounts of the land and buildings at 31 December 2014 were HK\$116,250,000 (2013: HK\$115,850,000).

Impairment of available-for-sale financial investments

The Group classifies certain assets as available-for-sale financial investments and recognises movements in their fair values in equity. When the fair value declines, management makes assumptions about the decline in value to determine whether there is an impairment that should be recognised in the income statement. At 31 December 2014, no impairment losses have been recognised for available-for-sale financial investment (2013: Nil). The carrying amount of available-for-sale financial investment was HK\$680,000 (2013: HK\$680,000).

Impairment of other assets

The Group assesses whether there are any indicators of impairment for all other non-financial assets (other than inventories and deferred tax assets) and the Company's investments in subsidiaries at the end of each reporting period which are tested for impairment when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying value of an asset or a cash-generating unit exceeds its recoverable amount, which is the higher of its fair value less costs to sell and its value in use. The calculation of the fair value less costs to sell is based on available data from binding sales transactions in an arm's length transaction of similar assets or observable market prices less incremental costs for disposing of the asset. When value in use calculations are undertaken, management must estimate the expected future cash flows from the asset or cash-generating unit and choose a suitable discount rate in order to calculate the present value of those cash flows.

For management purposes, the Group is organised into business units based on its products and services and has three reportable operating segments as follows:

- (a) the precision parts and components segment comprises the manufacture and sale of precision parts and components comprising keypads, synthetic rubber and plastic components and parts, and liquid crystal displays;
- (b) the consumer electronic products segment comprises the design, manufacture and sale of consumer electronic products comprising time, weather forecasting and other products; and
- (c) the corporate and others segment comprises the Group's long term investments, together with corporate income and expense items.

Management, the chief decision makers, monitors the results of the Group's operating segments separately for the purpose of making decisions about resource allocation and performance assessment. Segment performance is evaluated based on reportable segment results, which is a measure of adjusted profit/ loss before tax from continuing operations. The adjusted profit/ loss before tax is measured consistently with the Group's profit/ loss before tax except that bank interest income and finance costs are excluded from such measurement.

Intersegment sales and transfers are transacted with reference to the cost of sales.

Intersegment management fee is eliminated on consolidation.

Pursuant to the Mainland China Corporate Income Tax Law, a 10% withholding tax is levied on dividends declared to foreign investors from foreign investment enterprises established in Mainland China. The requirement is effective from 1 January 2008 and applies to earnings after 31 December 2007. A lower withholding tax rate may be applied if there is a tax treaty between Mainland China and the jurisdiction of the foreign investors. The Group is therefore liable to withholding taxes on dividends to be distributed by those subsidiaries established in Mainland China in respect of earnings generated from 1 January 2008 onwards.

At 31 December 2014, no deferred tax has been recognised for such withholding taxes that would be payable on the retained earnings of the Group's subsidiaries established in Mainland China that are subject to withholding taxes at distribution. 41. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The Group's principal financial instruments comprise interestbearing bank and other borrowings, and cash and short term deposits. The main purpose of these financial instruments is to raise finance for the Group's operations. The Group has various other financial assets and liabilities such as trade and bills receivables, prepayments, deposits and other receivables, trade payables, accrued liabilities and other payables and derivative financial instruments, which arise directly from its operations.

The main risks arising from the Group's financial instruments are interest rate risk, foreign currency risk, credit risk and liquidity risk. The board of directors reviews and agrees policies for managing each of these risks and they are summarised below.

Interest rate risk

The Group's exposure to the risk of changes in market interest rates relates primarily to the Group's long term debt obligations with a floating interest rate.

The Group's funding policy uses short term interest-bearing debts to finance its working capital requirements and interest-bearing debts over one year or internal generated resources to finance its capital investments. The Group borrows mainly at floating interest rates and the use of fixed rate interest-bearing debts over one year will only be considered for capital investments and under favourable market conditions.

Foreign currency risk

The Group has transactional currency exposures. Such exposures arise mainly from (i) the operating units in Hong Kong which maintain cash in Hong Kong dollar, their functional currency, but make sales in United States dollar. (ii) the majority of the transactions of the operating units in the PRC are denominated in RMB but their funds are mainly sourced from Hong Kong operating units.

In view of the fact that the Hong Kong dollar is pegged to the United States dollar, the Group's exposure to USD foreign currency risk is minimal. The Group tries to match its assets and liabilities denominated in RMB. Details of the currency exposure of the forward currency contracts are included in note 27 to the financial statements. The following table demonstrates the sensitivity at the end of the reporting period to a reasonably possible change in the RMB exchange rate, with all other variables held constant and excluding the effect of the forward currency contracts, of the Group's profit after tax (due to changes in the fair value of monetary assets and liabilities).

Credit risk

The Group trades only with recognised and creditworthy third parties. It is the Group's policy that all customers who wish to trade on credit terms are subject to credit verification procedures. In addition, receivable balances are monitored on an ongoing basis and the Group's exposure to bad debts is not significant.

The credit risk of the Group's other financial assets, which comprise cash and cash equivalents, deposits and other receivables, arises from default of the counterparty, with a maximum exposure equal to the carrying amounts of these instruments. The Company is also exposed to credit risk through the granting of financial guarantees, further details of which are disclosed in note 35 to the financial statements.

Concentrations of credit risk are managed by customer/counterparty, by geographical region and by industry sector. As at 31 December 2014, there is a significant concentration of credit risk as 15% (2013: 15%) of the balance representing a receivable from a single customer (2013: single customer), which was derived from sales by the precision parts and components segment.

Further quantitative data in respect of the Group's exposure to credit risk arising from trade and bills receivables are disclosed in note 23 to the financial statements.

At 31 December 2014 and 2013, the Company provided guarantees to banks and other financial institution in connection with facilities granted to subsidiaries repayable on demand of approximately HK\$45,723,000 and HK\$26,368,000, respectively.

Included in the contractual undiscounted payments of interest-bearing bank and other borrowings is an amount of HK\$5,418,580 (2013: HK\$8,017,964) of which the loan agreements contain a repayment-on-demand clause giving the bank the unconditional right to call in the loans at any time.

Notwithstanding the repayment-on-demand clause, the directors consider that these loans will be repaid in accordance with the scheduled dates as set out in the loan agreements. This evaluation was made considering: the financial position of the Group at the date of approval of the financial statements; the Group's compliance with the loan covenants; the lack of events of default, and the fact that the Group has made all previously scheduled repayments on time. In accordance with the terms of the loans, the contractual undiscounted payments at 31 December 2014 are set out in the above maturity profile.

Capital management

The primary objectives of the Group's capital management are to safeguard the Group's ability to continue as a going concern and to maintain healthy capital ratios in order to support its business and maximise shareholders' value.

The Group manages its capital structure and makes adjustments to it in light of changes in economic conditions. To maintain or adjust the capital structure, the Group may adjust the dividend payment to shareholders, return capital to shareholders or issue new shares. The Group is not subject to any externally imposed capital requirement. No changes were made in the objectives, policies or processes for managing capital during the years ended 31 December 2014 and 2013.
